# ATTACHED PROVISIONS TO ARTICLES OF INCORPORATION OF BALLANTYNE RESIDENTIAL ASSOCIATION, INC.

In accordance with Section 55A-14-03 of the North Carolina Nonprofit Corporation Act, the Association may be dissolved with the approval given in writing and signed by the Board of Directors and the assent given in writing signed by all Representatives entitled to cast votes under the Bylaws of the Association, and only in connection with a termination of the Declaration (hereafter defined) in accordance with Section 8.1(b) of the Declaration. Upon dissolution of the Association, the assets thereof shall, after all liabilities and obligations of the Association have been paid, or adequate provision made therefor, be distributed as follows: (1) assets held by the Association upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements; and (2) the remainder of the assets, if any, shall be distributed to the Owners in accordance with their Pro-rata Share as set forth in Exhibit B to the Declaration. Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Declaration of Easements, Covenants, Conditions, and Restrictions by CC Ballantyne, LLC, a Delaware limited liability company, CCP Harmon Ballantyne PropCo, LLC, a Delaware limited liability company, and CC Ballantyne MDE, LLC, a Delaware limited liability company in the Office of the Register of Deeds for Mecklenburg County (the "Declaration").
