WHEREAS, the Declarant created the University East Professional Center Condominium #1 by Declaration dated March 23, 1999, and filed for record in Book 10340 at Page 559 in the Mecklenburg County Public Registry (herein called the "Declaration"); and

WHEREAS, the Declaration provided in Article II, Section 2.4 thereof that Unit 2A may be subdivided in accordance with Section 47C-2.113 of the Act; and

WHEREAS, the Articles of Incorporation of the University East Professional Center Condominium #1 Association, Inc. (the "Association") were filed with the Secretary of State of North Carolina on February 12, 1999; and

WHEREAS, Section 47C-2.113 of the Act provides that if a declaration expressly so permits a unit may be subdivided into two or more units and upon application of a unit owner, the association, at the expense of the unit owner shall prepare, execute and record an amendment to the declaration, including plats and plans, subdividing the unit; and

WHEREAS, Declarant desires to subdivide Unit 2A as described in the Declaration into two Condominium Units known as 1C and 2B;

NOW, THEREFORE, the Declarant and the Association do hereby publish and declare that Condominium Unit 2A described in the Declaration is hereby subdivided into Condominium Unit 1C and 2B. Unit 1C, formerly described in the Declaration as the unshaded portion of the First Floor, shall be renamed 2A to avoid confusion. The Declaration is specifically incorporated herein by reference.

Supplemental plans for Units 2A and 2B showing floor and ceiling elevations, prepared by Overcash Demmitt Architects, and consisting of 1 sheet, are incorporated herein by reference and have been filed this date and appear in the Unit Ownership File No. 491, Page 5 in the Mecklenburg County Public Registry. The shaded portion shall be designated as 1C and the unshaded portion as 2B.
