THIS SECOND AMENDMENT TO DECLARATION is made and executed this day of \_\_\_\_\_\_\_\_\_\_, 2000, by UNIVERSITY EAST, LLC, a North Carolina limited liability company, hereinafter called the "Declarant," for itself, its successors, grantees, and assigns, pursuant to the provisions of the North Carolina Condominium Act ("The Act"), Chapter 47C, North Carolina General Statutes.

### WITNESSETH:

WHEREAS, the Declarant created the University East Professional Center Condominium #1 by Declaration dated March 23, 1999, and filed for record in Book 10340 at Page 559 in the Mecklenburg County Public Registry (herein called the "Declaration"); and

WHEREAS, the Articles of Incorporation of the University East Professional Center Condominium #1 Association, Inc. (the "Association") were filed with the Secretary of State of North Carolina on February 12, 1999; and

WHEREAS, the Declaration provided in Article II, Section 2.4 thereof that certain Units described therein may be subdivided in accordance with Section 47C-2.113 of the Act and Article II, Section 2.9. thereof reserves certain rights to the Declarant, including the right to subdivide units; and

WHEREAS, Declarant and Association did subdivide Condominium Unit 2B into two Condominium Units known as 1C and 2B by Amendment recorded in Book 10538, Page 708, Mecklenburg County Public Registry (the "First Amendment"); and

WHEREAS, Declarant desires to subdivide Unit 2B as described in the First Amendment into two Condominium Units known as 1E and 2B; and

WHEREAS, Declarant desires to subdivide Unit 2A as described in the First Amendment into two Condominium Units known as 1B and 2A.

NOW, THEREFORE, the Declarant and the Association do hereby publish and declare. that Condominium Unit 2B described in the First Amendment is hereby subdivided into Condominium Units 1E and 2B and does further publish and declare that Condominium Unit 2A described in the First Amendment is hereby subdivided into Units 1B and 2A. The Declaration and the First Amendment are specifically incorporated herein by reference.

Supplemental plans for Units 2A and 2B showing floor and ceiling elevations, prepared by Overcash Demmitt Architects, and consisting of 2 sheets, are incorporated herein by reference and have been filed and appear in the Unit Ownership File No. 491, Pages 7 and 8 in the
